



## Terms and conditions

1. Ballyconnell Credit Union will ensure that projects which are awarded funding are consistent with the ethos and values of the Credit Union movement and will be distributed throughout the common bond in a fair and equitable manner.
2. The Community fund is open to all community or voluntary groups, local clubs or associations, schools, not-for-profit and charitable organizations working at a local level within our common bond.
3. All applications for support will be considered by our Community Fund Committee. Our Board of Directors will approve final decisions.
4. To be eligible, applicants must be located within our Common Bond area.
5. Your Chairperson or Secretary should complete the application form on behalf of your Organisation or Group.
6. Ballyconnell Credit Union will require your Chairperson or Secretary to liaise with us on your application.
7. Only groups or organisations will be considered. Ballyconnell Credit Union does not sponsor individuals or commercial organisations under our Community Fund.
8. All applicants will be notified of the outcome of their application.
9. Ballyconnell Credit Union does not guarantee recurring support, and any applicant can reapply for support each year the Community Fund is open.
10. All applications must state how our Community will benefit from support from the fund.
11. Ballyconnell Credit Union requests that the organisation or group acknowledges the support received on their website, social media sites of Facebook, Twitter, Instagram etc or local media.
12. All support under the fund is subject to agreement that BCU can publicise this and their name on its social media, web pages, AGM Booklet or any local media.
13. Failure to adhere to these terms and conditions could preclude any organisation from further support.
14. We would like to be able to update our members on progress of successful applications in the future.
15. Funding will be made electronically to the groups Credit Union or bank account held in their name. We cannot issue cheques or cash to individuals.
